#### Information about the Service

This service is a fixed line telephone with a monthly access fee, available to both residential and business customers. It is not part of a product bundle, and you must supply your own handset/s. Minimum term is 12 or 24 months.

The monthly access fee includes line rental, local, national, fixed to mobile calls and unlimited data. Other types of calls are charged in addition to the monthly access fee.

Other important conditions:

- Offer available to approved customers only.
- Services are provided under our Standard Form of Agreement – see our website
- Early termination charge applies (except during any applicable cooling off period).

The price is based on a zone 1 ADSL2+ access.

This service is broadband over ADSL technology with a monthly access fee. You may supply your own modem or purchase from us at additional cost. The monthly access fee includes unlimited data on ADSL or ADSL 2+ where available.

Payment through Direct Debit Only.

#### Information About Pricing:

The minimum monthly charge is the monthly access fee of \$139.95. The maximum monthly charge depends on the number and type of calls that are not included in the monthly access fee.

Local Calls, Calls to mobiles and National Calls are unlimited. Calls to 13/1300 numbers are charged at \$0.45 per call untimed. Flag fall are charged at \$0.35 (International ONLY) on timed calls. Charges for international calls vary by location – check our website for current details. 1900 and other premium service calls are subject to varying charges – check before dialing. Included data is unlimited. DSL applicable to Zone 1.

The minimum total plan cost is \$1679.4 over 12 months and \$3358.8 over 24 months.

The early termination charge is \$350.

In the event that the customer cancels the voice services and the Internet services remains, the early termination fee will be \$175; in the event that the voice services remain and the customer cancels the Internet service, the early termination charge will be \$175.
